- 3. The candidate will be treated as a Full Time Research Scholar & work as Research Scholar, Dept of Pharmacology, Krupanidhi College of Pharmacy, Chikkabellandur, Carmelaram Post, Varthur Hobli, Bengaluru, Duration of the course shall be for a minimum period of Three years commencing from September-2020. The maximum period shall be seven years.
- 4. The shift from full time to part time duration will be permitted with prior approval from the University, whereas shift from part time to full time duration is not permitted.
- 5. The candidate is hereby directed to submit ethical clearance certificate in original from the appropriately constituted Ethical Committee (separate for experiments on humans and experiments on animals) through The Principal, Krupanidhi College of Pharmacy, Chikkabellandur, Carmelaram Post, Yarthur Hobli, Bengaluru, within six months from the date of provisional registration wherever applicable.
